Note: You can show an unsanctioned breed of rabbit and win Grand Champion legs. Sanctions are for the purpose of national breed club members competing in sweepstakes points.

Show Rules

1. All entry fees must be paid to the show secretary prior to judging. Exhibitors who do not show up may be billed by MSRBA and no entries will be accepted until past entries have been paid. Returned check fee is \$15 plus the amount of the check. Entries scratched the day of show are still charged the entry fee.
2. MSRBA, being a member of the ARBA, will be governed by and run under the latest revised official show rules of the ARBA.
3. MSRBA reserves the right to refuse any entries.
4. Exhibitors attempting to or actually interfering with, annoying, molesting or influencing the judge will have their entries disqualified and be barred from the show.
5. Exhibitors behaving in an unsportsmanlike manner will have their entries disqualified and be barred from the show.
6. MSRBA is not responsible for any losses or damages for any reason.
7. This is a one day carrying cage show. Animals must be confined in leak-proof cages.
8. Advertisements are not permitted near the judging tables.
9. MSRBA can substitute judges in place of those listed or appoint additional judges. Your entry denotes acceptance of your assigned judge. Judging assignments are made prior to the show and the show staff will not necessarily honor requests for specific judges.
10. No alcohol, smoking, firearms or animals other than rabbits and cavies are allowed in the showroom.
11. All entered rabbits must be legibly tattooed in the left ear. Cavies must have ear tags.
12. Any diseased or unsightly animals will be refused entry and removed from the showroom by the show superintendent. Entry fees will be forfeited.

13. All animals entered in fur or wool classes must also be entered in their regular breed class.
14. Animals not at the judge's table after being called three times may be disqualified.
15. Parents and guardians are responsible for their children's behavior and any damage they cause.
16. All animals, in accordance with Maine state law, must be over 8 weeks old to be sold.
17. ARBA Show rules SECTION 30. All animals must be the bonafide property of the exhibitor(s) prior to entry. Each owner's personal name(s) must be listed on the entry form, but a rabbitry name may be added, if applicable, when entering shows. It will be the responsibility of the owner(s) and Show Committee to not submit or accept an entry in family or rabbitry names.

18. SECTION 48. Any personally involved exhibitor within a Breed, Group, Variety, or Class shall have the right to make a written protest from the time of occurrence until two hours after awards are placed. (A) An official protest may only be submitted if: (1) A disqualified rabbit or cavy is placed. (2) A rabbit or cavy is wrongfully disqualified. (3) Alleged fraudulent practices on the part of any judge. Only one animal may be listed on a protest. Specific disqualifications, which are exempt from a protest, are identified in the ARBA Standard of Perfection.

(B) An official protest must be submitted in writing to the show superintendent with a \$25.00 protest fee. The protest must be signed and submitted by the actual exhibitor personally involved within the Breed. The protest shall then be acted upon by a committee of three members. The members shall consist of: (1) A member of the show committee. (2) An ARBA licensed judge or registrar, which shall be appointed by the show superintendent. (3) A disinterested ARBA member agreed upon by the other two committee members. The written protest must then be presented to the Protest Committee for their evaluation.

(C) If the protest is sustained or allowed, the affected class(es) or awards shall be adjusted accordingly.

(D) If the protest is sustained, the \$25.00 protest fee shall be refunded. If the protest is not sustained or allowed, the \$25.00 deposit will be retained by the show sponsor.

18. ARBA Show Rules SECTION 51. Youth may not enter their rabbit or cavy in both open and youth classes at the same show, which is sponsored by the same club. Youth may make entries in both open and youth classes with different animals.

(A) When more than one ARBA sanctioned all breed or specialty show, not having a youth sanction, are held in conjunction on the same day, youth exhibitors may enter all additional shows with the same animals.

19. ARBA Show Rules SECTION 52. Youth exhibitors may enter sanctioned youth shows between the ages of five (5) and eighteen (18) years. An adult cannot show in youth classes at any time. Youth exhibitors must be able to handle their own animals. If stated in the show catalog, all youth entries must be carried by youth. Youth exhibitors are not required to carry their own animals to the table.
